

# **GRANT APPLICATION FORM**

# A. COVER LETTER (maximum one page)

- ✓ Date
- ✓ Name and full address of organization
- ✓ Statements summarizing the purpose and activities of the organization, the proposal, and project's relevance to the Foundation's mission
- ✓ The total project budget and the dollar amount being requested
- ✓ Previous support from the Christie Foundation
- ✓ Signature of the Executive Director or President of the organization

# **B. NARRATIVE** (maximum of three double-spaced pages)

- 1. Organization Information
  - ✓ Brief summary of organization's mission and history
  - ✓ Description of current programs, activities, and recent accomplishments

# 2. Purpose of Grant

- ✓ Statement of needs/problems to be addressed; description of how community will benefit
- ✓ Description of project goals and objectives (measurable, if possible)
- ✓ Timetable for implementation
- ✓ Other organizations, if any, participating in the project

### 3. Evaluation

✓ Plans for monitoring, evaluating, and sharing success

#### C. FINANCIAL INFORMATION

- ✓ Project budget (preferable), or narrative of what funds will used for
- ✓ Organization's prior year and current year annual budget
- ✓ Description of how the organization plans to track grant expenditures
- ✓ Other sources of revenue for the project with notations regarding status
- ✓ Previous gifts from the Foundation

#### **D. ATTACHMENTS**

The following attachments must be included in all grant applications:

- ✓ A copy of the current IRS determination letter indicating 501(c)(3) status
- ✓ Anti-discrimination statement
- ✓ Listing of Board of Directors and an organizational chart
- ✓ A statement detailing the publicity that would be associated with a grant from the Christie Foundation.
- ✓ Relevent media stories or other attachments relating to the project/organization

#### PLEASE NOTE

A Year End Report is required of each grant recipient specifying how grant monies were used and what impact the funding had on project goals.
